Mr. Mehrberg began his legal career in 1980 as an associate at Jenner & Block, where he became a partner in 1986. In 1993, he became general counsel and lakefront director for the Chicago Park District. He returned to the firm in 1997 and stayed until he joined Exelon as its general counsel in 2000. He rejoined Jenner & Block in 2016 after serving in public and private sector positions including as senior advisor to the mayor of Chicago and executive vice president and general counsel at Vail Resorts.
